Value-chain reporting begins for the top 250 companies from FY 2025–26, expanding ESG accountability across suppliers and partners.



CCTS

India's Carbon Credit Trading Scheme covers nine high-emission sectors (steel, cement, fertilizer, etc.) in its first phase, with plans to add four more sectors soon.



CBAM

The EU's Carbon Border Adjustment Mechanism currently covers six energy-intensive sectors, with plans to expand its scope to additional sectors in the coming years.




